Some actions we take across states include:


- Getting health-harming toxics out of everyday products

Skip the Stuff

Clean Water Action's ReThink Disposable program is working to stop plastic trash advocating for a "Skip the Stuff" bill in New Jersey

- ~40 billion individual single-use plastic utensils are discarded every year in the United States
- Plastic has recently been found making its way to our **bloodstream and then into breast milk** and the heart
- Most plastic utensils are unused and an unnecessary cost burden to restaurants
- Since 2014, online food ordering has **increased 300% faster than dine-in**, furthering the plastic pollution problem.

New Jersey Needs to **'Skip the Stuff''** When Getting Take-Out

- Restaurants should only give out single-use cutlery and condiment containers if requested by customers.
- First ordinance passed in April 2020 in Maplewood, NJ
- Urge your town to pass a "Skip the Stuff" ordinance (Contact Marta Young)
- New Jersey needs to pass a "Skip the Stuff" bill so we can continue to be an environmental leader.





Warehouse & Port Pollution Bill



Correctional facilities often are sited near toxic industrial sites, potentially exposing thousands of people to dangerous contaminants. Detecting E. coli in their drinking water raises concerns about the adequacy of their sewer systems.



Engaging communities and gaining legislative support for the Warehouse & Port Pollution bill, (A4679/S3546).

This bill would curb pollution at warehouses and other truck attracting facilities by requiring them to implement concrete emission reduction measures.

Coalition for Healthy Ports



The Coalition for Healthy Ports' Mission is to improve Air Quality and Health of communities and workers, as well as ensure environmental justice is achieved in affected communities.
